3. Description of Services

Blueprint Tutors currently offers downloadable Al-generated practice questions and solutions tailored to the **Test of Mathematics for University Admission (TMUA)**. The TMUA is used by several UK universities – including but **not limited** to Cambridge, Imperial College London, LSE, UCL, Warwick and Durham – as part of their admissions process.

Independence & No-Affiliation – Blueprint Tutors is an independent provider of revision resources. We are not affiliated, associated, authorised, endorsed by, or in any way officially connected with any university, school, examination board, UAT-UK, Pearson

VUE, or any admissions testing service. References to specific exams or institutions are purely for descriptive and comparative purposes.

Possible Future Expansion – Our catalogue may in future include resources for **other admissions tests or subjects (mathematics or otherwise)**. Unless we publish updated Terms, this agreement applies equally to any additional materials.

Download-Only Delivery – At present we do **not operate a user account or gated portal**. After payment is confirmed you will receive a secure link (or email attachment) to download the Digital Product. You are responsible for storing a backup of the file; you may request **one** complimentary replacement link within 30 days of purchase; thereafter any re-issue is at our discretion and may incur a small administrative fee.
